A GUIDE TO REGISTERING YOUR HORSE

Prior to taking your mare to stud, you should check with the Association that the stallion owner is a financial member of AHAA. Your application for Registration of Foal should be forwarded to the Secretary within 12 months of the foaling date. It must be accompanied by the appropriate fee plus the Duplicate Service Certificate. You must be a Full member of the Association to register a horse. The Breeder (as required by this Association) is the person who owns the mare or who is the AHAA registered lessee at the time of foaling.

A Certificate of Registration will be sent to you when the registration process is complete.

Registration of Pure Spanish/Purebred Iberian / Hispano-Arabe:

All foals must be microchipped, DNA tested and parent validated before registration. Microchip and DNA application forms can be downloaded from the AHAA website. Adding brands is optional. After receiving the Microchip and DNA application forms accompanied by the appropriate fees, the Secretary will send you a DNA kit, microchip and the application for registration form which will have a section on the front for your veterinarian to sign. Complete the form and return it to the Secretary. Your veterinarian will send the DNA sample to the laboratory in the enclosed addressed and reply-paid envelope. Please Note: Progeny of unregistered parents will not be accepted for registration.

Registration of Australian Andalusian / Partbred Andalusian:

All foals must be microchipped. Adding brands is optional. Microchip application forms and Foal Registration application forms can be downloaded from the AHAA website. If using a microchip other than the AHAA one, please note the number on the Application for Registration form. After receiving the Microchip application form and fee, the Secretary will send you a microchip and application for registration form which will have a section on the front for your veterinarian to sign. Complete the form and return to the Secretary.

Registration of Andalusian Derivative:

All foals must be microchipped. Adding brands is optional. Microchip application forms and Foal Registration application forms can be downloaded from the AHAA website. If using a microchip other than the AHAA one, please note the number on the Application for Registration form. After receiving the Microchip application form and fee, the Secretary will send you a microchip and Application for Registration form which will have a section on the front for your veterinarian to sign. Complete the form and return to the Secretary.

For AHAA registered first and second cross mares joined to another breed stallion, a service certificate or Statutory Declaration from the stallion or mare owner will be required for registration.

Horses that do not fit the above criteria may apply for registration consideration and cases will be considered on an individual basis.

Fees:

\$100 Registration fee for Pure Spanish/Purebred Iberian/Hispano-Arabe

\$80 Registration fee for Australian Andalusians

\$60 Registration fee for Partbred Andalusians, Andalusian Derivatives and all geldings.

\$90 DNA

\$20 Microchip
